

Terms & Conditions – ANTHARPRERANA, Thiruvananthapuram

These Terms & Conditions ("Terms") govern the participation of delegates ("you", "attendee") attending ANTHARPRERANA – Thiruvananthapuram ("Event"), organised by RankRizers ("we", "us", "our").

By purchasing a ticket, registering for, or attending the Event, you agree to comply with these Terms.

1. Delegate Access & Participation

- The Event is open **only to registered and paid delegates**.
- Entry will be granted only upon presentation of a **valid registration confirmation, QR code, badge, or official ID**, as applicable.
- RankRizers reserves the right to **deny entry or remove any delegate** who violates these Terms or disrupts the Event.

2. Code of Conduct

All delegates are expected to:

- Conduct themselves in a **professional, respectful, and courteous manner**.
- Refrain from harassment, discrimination, intimidation, abusive language, or disruptive behaviour.
- Respect speakers, fellow delegates, sponsors, partners, volunteers, and event staff.
- Follow instructions issued by the event organisers and venue authorities.

Any violation may result in **immediate removal from the Event without refund**.

3. Tickets, Pricing & Registration

- All tickets are **non-transferable**, unless explicitly stated by RankRizers.
- Tickets are **non-refundable and non-cancellable**, except where mandated by applicable law.

 - Modify the Event agenda, speakers, sessions, timings, or venue
 - Make operational or logistical changes as required

Such changes shall not entitle delegates to refunds.

4. Photography, Audio & Video Recording

- The Event may be photographed, audio-recorded, or video-recorded.
- By attending the Event, you grant RankRizers the **irrevocable right** to capture, use, reproduce, and distribute your image, voice, or likeness for:
 - Event documentation and recaps
 - Marketing, branding, and promotional purposes
 - Digital platforms, websites, and social media

If you do not wish to be recorded, you must **inform the registration desk prior to event entry**. RankRizers will make reasonable efforts to accommodate such requests, where feasible.

5. Personal Data Collection, Use & Consent (DPDPA-Aligned)

- By registering for and attending the Event, you **freely, specifically, informedly, and unambiguously consent** to RankRizers collecting, storing, and processing your personal data, including but not limited to **name, contact details, organisation, and designation**, for purposes related to:
 - Event registration and participation
 - Event communication and administration
 - Event reporting and analysis
- You further **consent to the sharing** of your registration data with **Event sponsors, partners, exhibitors, and stall owners** for:
 - Event-related communication
 - Marketing, promotional, and informational outreach
 - Business, networking, or partnership opportunities
- You acknowledge that such third parties may **contact you directly** via email, phone, SMS, or digital channels.

- RankRizers acts as a **data fiduciary** only for Event-related processing and does not control the data practices of third parties once shared.
- You have the **right to withdraw consent** for future communications at any time by:
 - Using unsubscribe mechanisms provided by the respective third party, or
 - Writing to antharpreranatvpm@rankrizers.com for reasonable assistance

Withdrawal of consent shall not affect the lawfulness of processing carried out prior to such withdrawal.

6. Intellectual Property Rights

- All content presented at the Event, including but not limited to:

 - Branding and event materials are protected by applicable intellectual property laws.
- Recording, reproducing, distributing, or using Event content for **commercial purposes** without prior written consent from RankRizers is strictly prohibited.

7. Health, Safety & Personal Responsibility

- Delegates must comply with all **venue rules, safety regulations, and applicable laws**.
- Attendance is at your own risk.
- RankRizers shall not be responsible for:
 - Personal injury
 - Loss, theft, or damage to personal belongings unless required under applicable law.

8. Limitation of Liability

To the maximum extent permitted by law:

- RankRizers shall not be liable for any **indirect, incidental, special, or consequential**

damages arising from participation in the Event.

- Any liability, if established, shall be limited to the **ticket amount paid by the delegate**.

9. Force Majeure

RankRizers shall not be held liable for failure or delay in conducting the Event due to circumstances beyond reasonable control, including but not limited to natural disasters, government restrictions, pandemics, strikes, or technical failures.

10. Governing Law & Jurisdiction

These Terms shall be governed by and interpreted in accordance with the laws of **India**, with exclusive jurisdiction in **Thiruvananthapuram, Kerala**.
